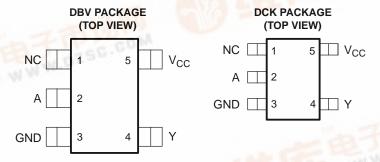

#### **DESCRIPTION/ORDERING INFORMATION**

This single Schmitt-trigger buffer is designed for 1.65-V to 5.5-V V<sub>CC</sub> operation.

The SN74LVC1G17-Q1 contains one buffer and performs the Boolean function Y = A. The device functions as an independent buffer, but because of Schmitt action, it may have different input threshold levels for positive-going  $(V_{T+})$  and negative-going  $(V_{T-})$  signals.

This device is fully specified for partial-power-down applications using I<sub>off</sub>. The I<sub>off</sub> circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

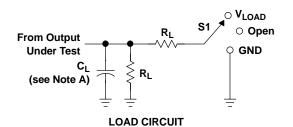

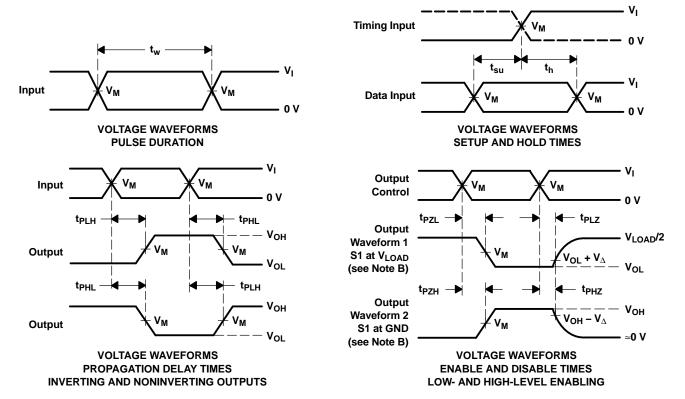

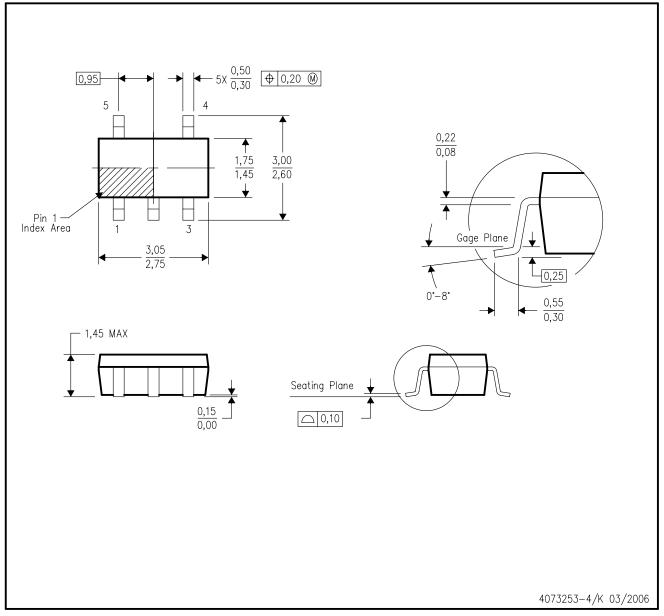

# PLASTIC SMALL-OUTLINE PACKAGE



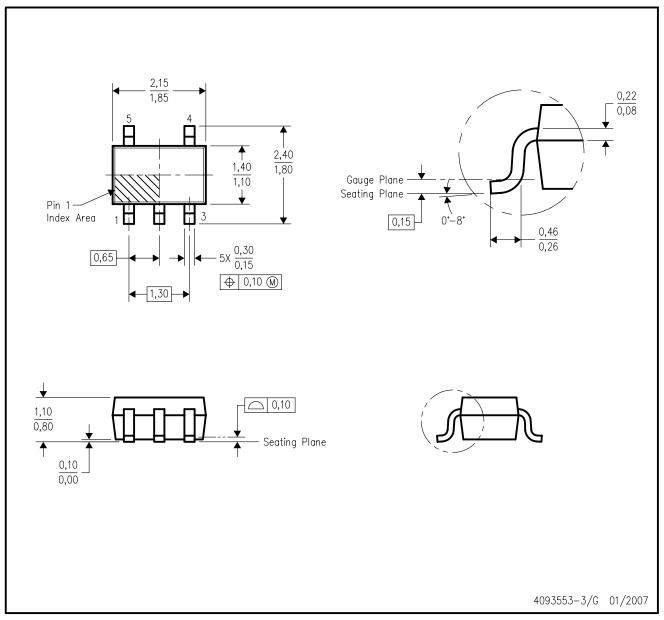
