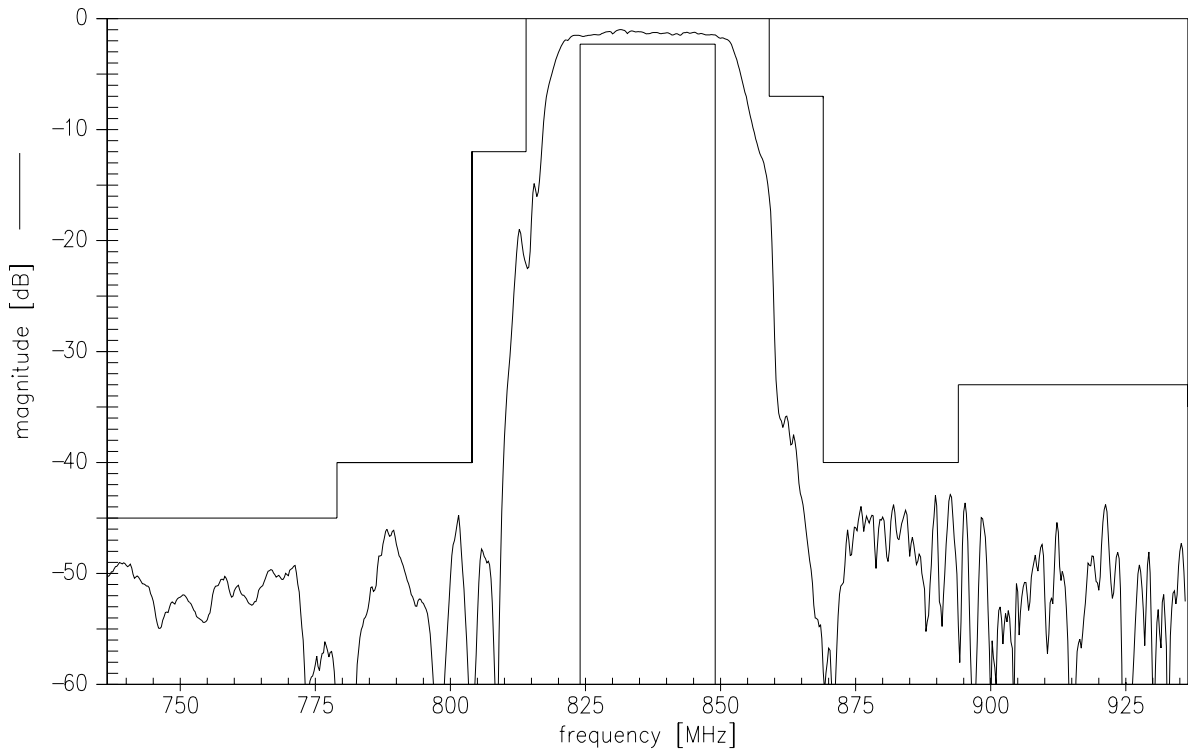

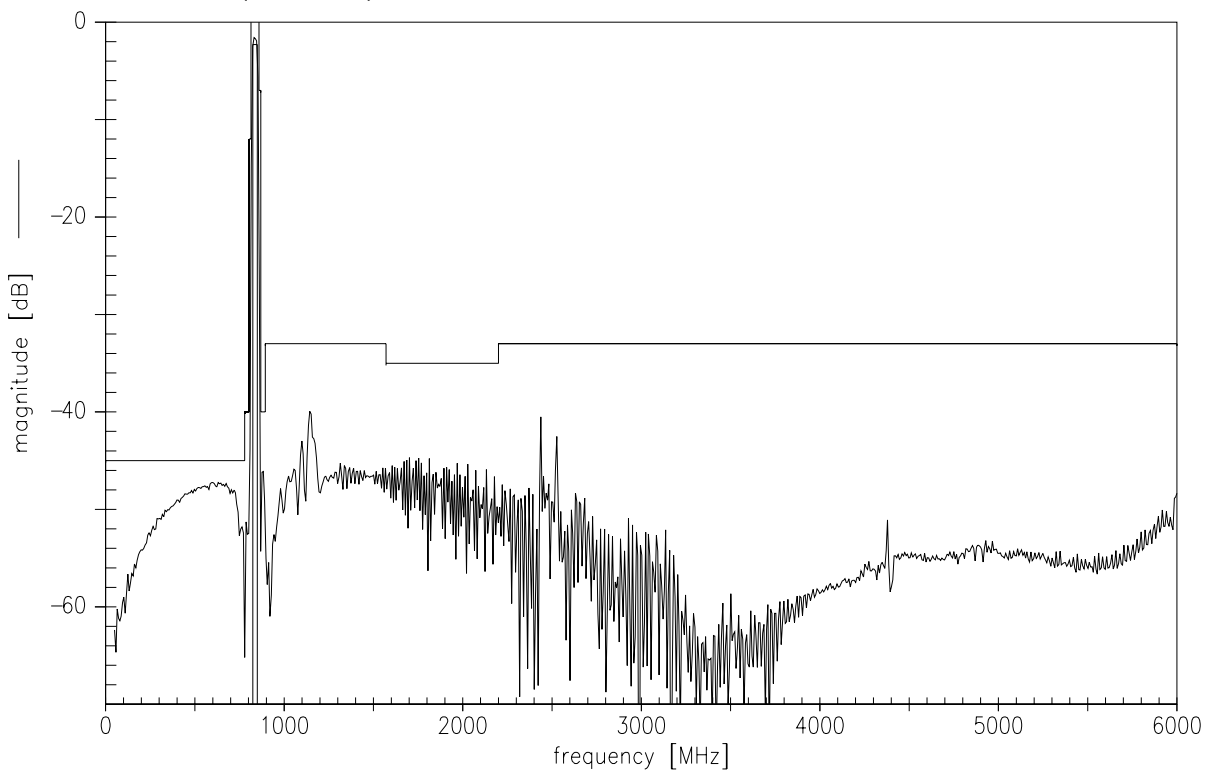

Transfer function (wideband)





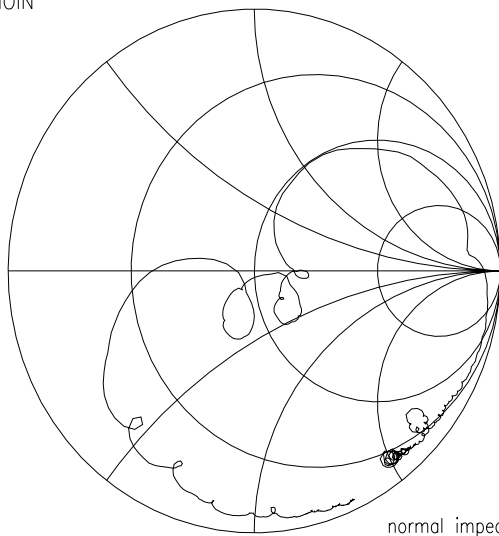

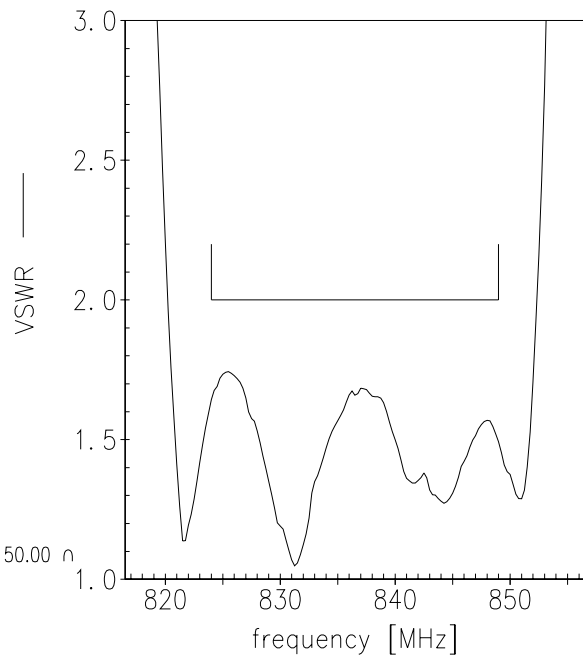
S_{11} function

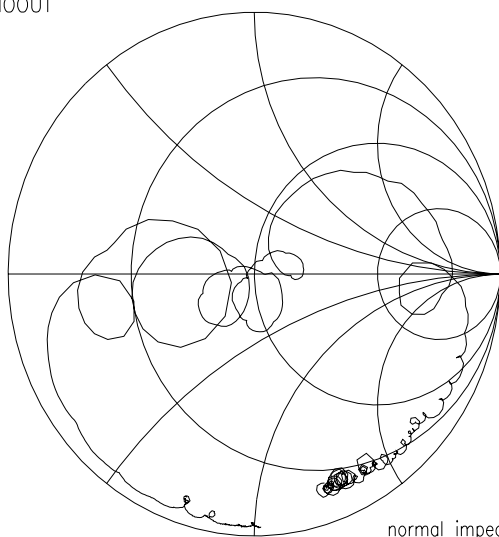

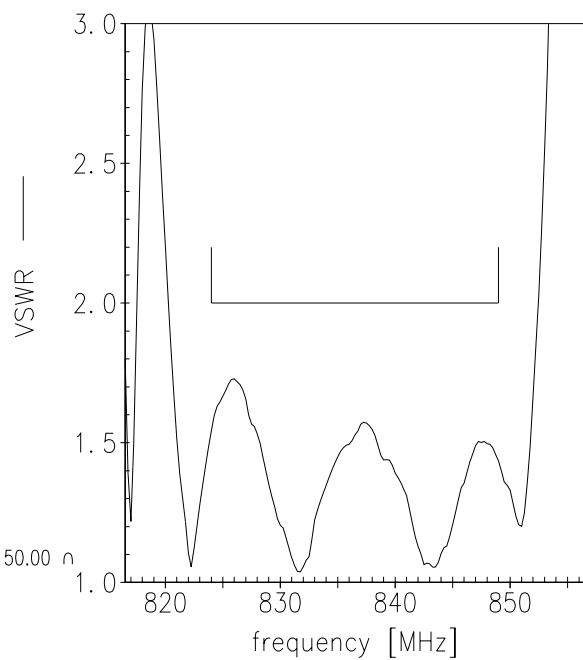
S_{22} function
