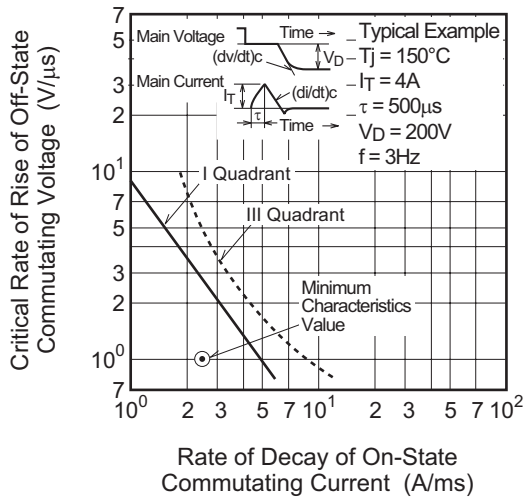

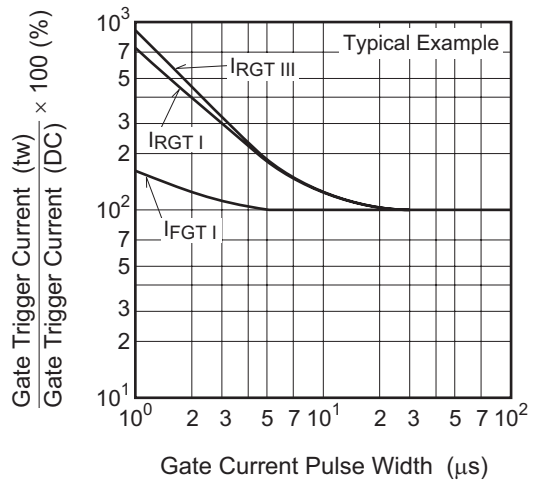

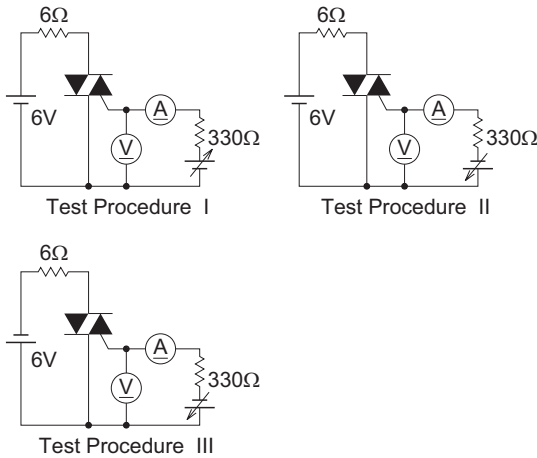
Commutation Characteristics ( $T_j=150^\circ\text{C}$ )



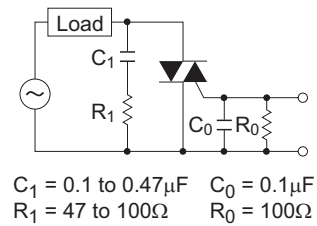
Gate Trigger Current vs. Gate Current Pulse Width



Gate Trigger Characteristics Test Circuits

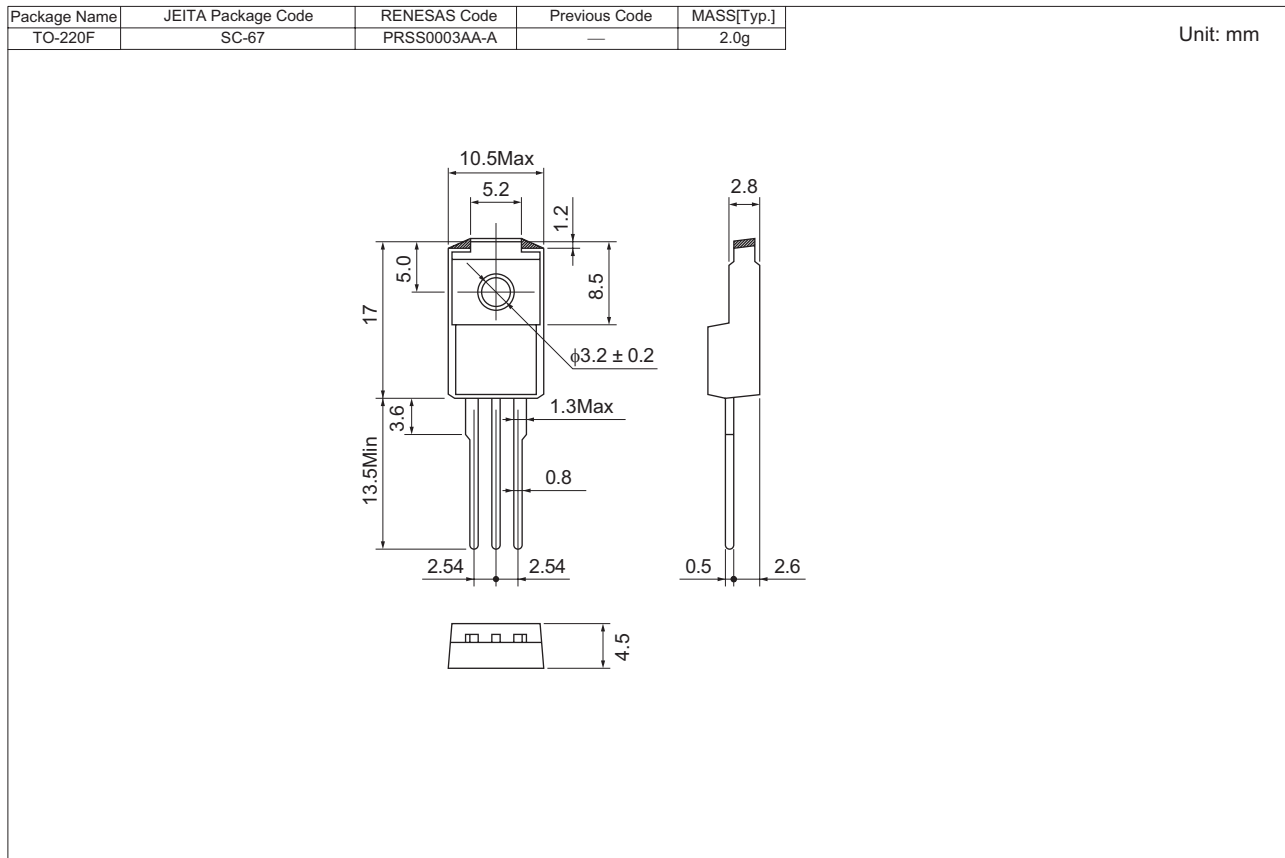
