
Forward Current vs. Collector **Dissipation Temperature Rating** 










**Response Time vs. Load Resist**ance Characteristics (Typical)






**Relative Light Current vs. Ambi**ent Temperature Characteristics (Typical)












#### Light Current vs. Forward Current Characteristics (Typical)
