



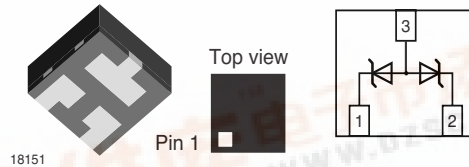

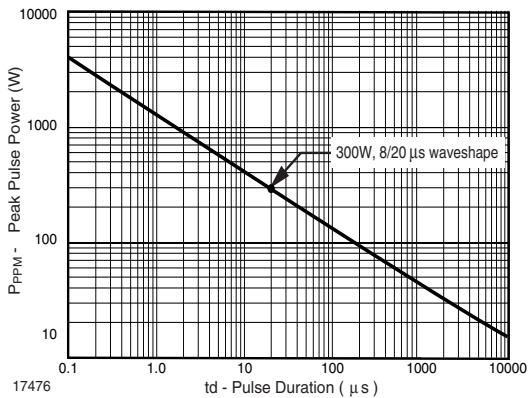


Figure 1. Non -Repetitive Peak Pulse Power vs. Pulse Time

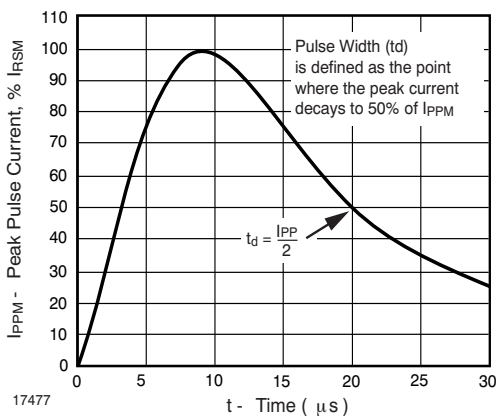


Figure 2. Pulse Waveform

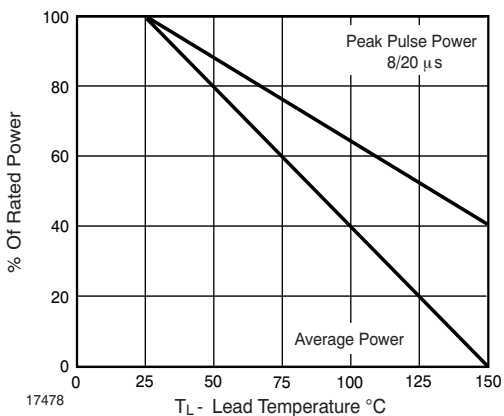


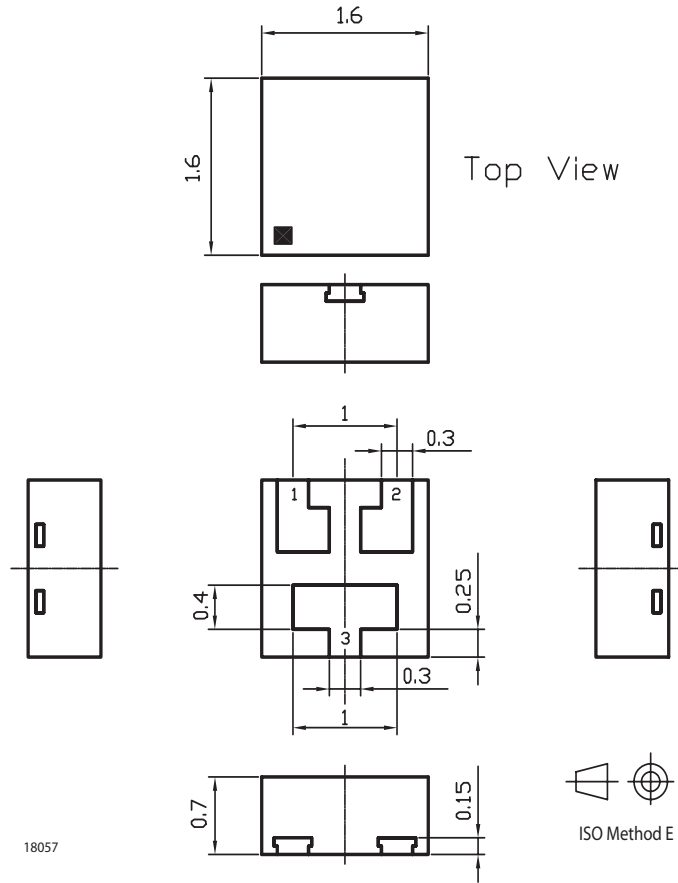
Figure 3. Power Derating

## Ozone Depleting Substances Policy Statement
