



Fig.1 Ground Emitter Propagation Characteristics





Fig.2 Typical Output Characteristics

Fig.3 DC Current Gain vs. Collector Current(I)





Fig.4 DC Current Gain vs. Collector Current(II)

Fig.6 Collector-Emitter Saturation Voltage


Fig.7 Base-Emitter Saturation Voltage




COLLECTOR OUTPUT CAPACITANCE: Cob [pF]

EMITTER INPUT CAPACITANCE: Cib [pF]



Collector-Base Voltage




COLLECTOR - BASE VOLTAGE : V_{CB} [V] EMITTER - BASE VOLTAGE : V_{EB} [V]


Fig.10 Safe Operating Area
