DESCRIPTION

The PS9121 is an optically coupled high-speed, active low type isolator containing a GaAlAs LED on the input side and a photodiode and a signal processing circuit on the output side on one chip.

The PS9121 is designed specifically for high common mode transient immunity (CMR) and low pulse width distortion. The PS9121 is suitable for high density application.




USAGE CAUTIONS

- 2. By-pass capacitor of 0.1 μ F is used between Vcc and GND near device. Also, ensure that the distance between the leads of the photocoupler and capacitor is no more than 10 mm.
- 3. Avoid storage at a high temperature and high humidity.








OUTPUT VOLTAGE vs. INPUT CURRENT




DETECTOR POWER DISSIPATION vs. AMBIENT TEMPERATURE



SUPPLY CURRENT vs. AMBIENT TEMPERATURE




LOW LEVEL OUTPUT VOLTAGE vs. AMBIENT TEMPERATURE




THRESHOLD INPUT CURRENT vs. AMBIENT TEMPERATURE



PULSE WIDTH DISTORTION vs. AMBIENT TEMPERATURE




PROPAGATION DELAY TIME vs. INPUT CURRENT




PROPAGATION DELAY TIME vs. AMBIENT TEMPERATURE




SWITCHING TIME vs. AMBIENT TEMPERATURE


