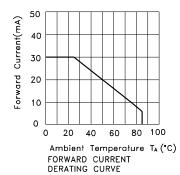


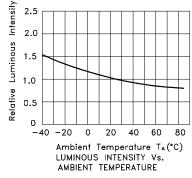
RELATIVE INTENSITY Vs. WAVELENGTH

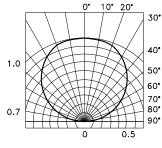

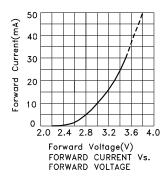


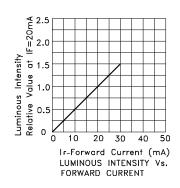


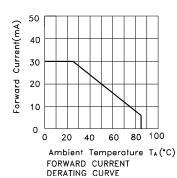
SPATIAL DISTRIBUTION

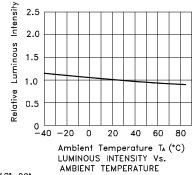

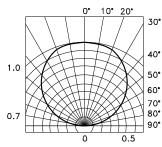

SPATIAL DISTRIBUTION

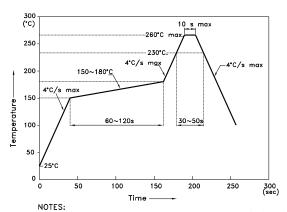
