#### DESCRIPTION

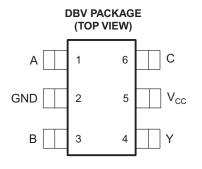
This device is designed for 1.65-V to 5.5-V  $V_{CC}$ operation.

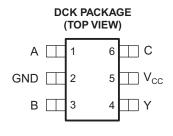
The SN74LVC1G0832 device is a single 3-input positive AND-OR gate. It performs the Boolean function  $Y = (A \cdot B) + C$  in positive logic.

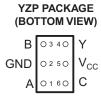
By tying one input to GND or  $V_{CC}$ , SN74LVC1G0832 device offers two more functions. When C is tied to GND, this device performs as a 2-input AND gate (Y = A • B). When A is tied to V<sub>CC</sub>, the device works as a 2-input OR gate (Y = B + C). This device also works as a 2-input OR gate when B is tied to  $V_{CC}$  (Y = A + C).

NanoFree™ package technology is a major breakthrough in IC packaging concepts, using the die as the package.

This device is fully specified for partial-power-down applications using  $I_{\text{off}}$ . The  $I_{\text{off}}$  circuitry disables the outputs, preventing damaging current backflow through the device when it is powered down.

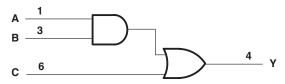

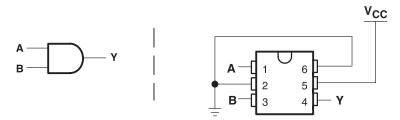


Figure 1. 2-Input AND Gate

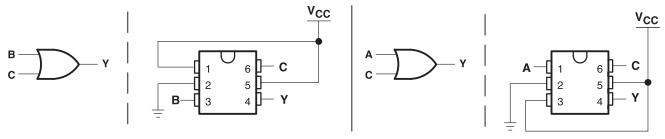


Figure 2. 2-Input OR Gate

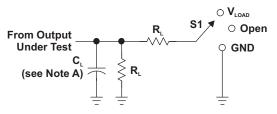

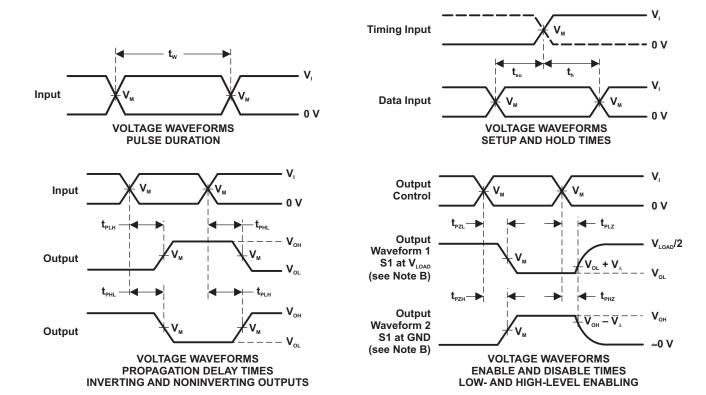
