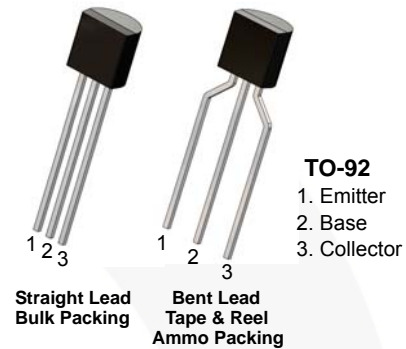

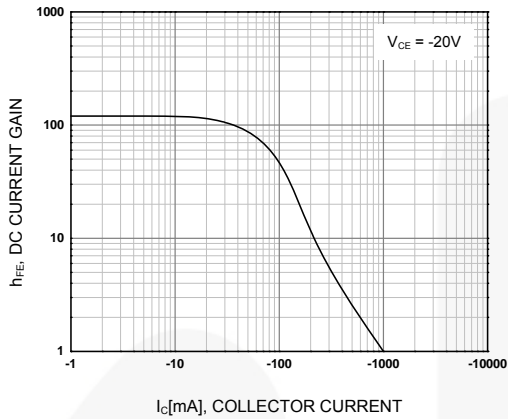


Figure 1. DC Current Gain

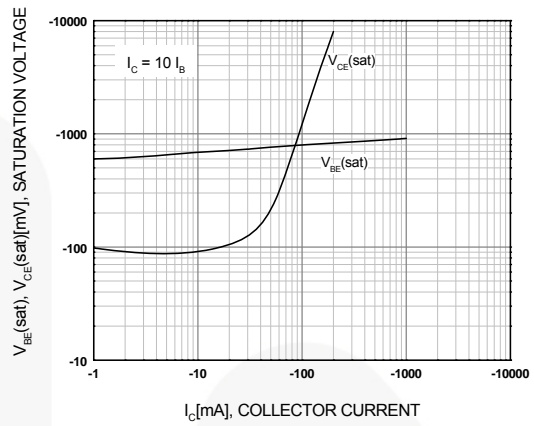


Figure 2. Base-Emitter Saturation Voltage and Collector-Emitter Saturation Voltage

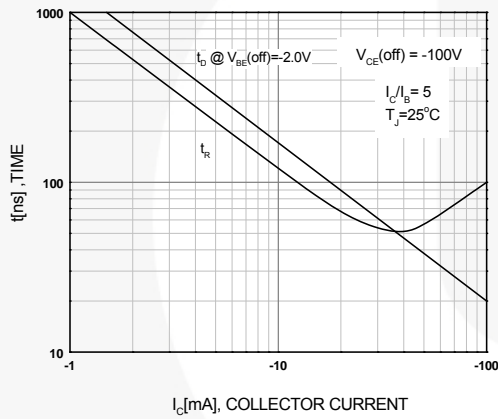


Figure 3. Turn-On Time

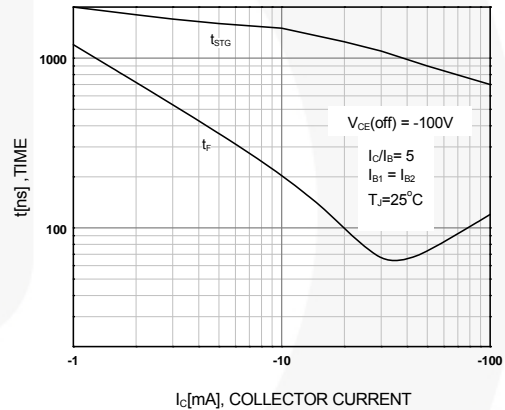


Figure 4. Turn-Off Time

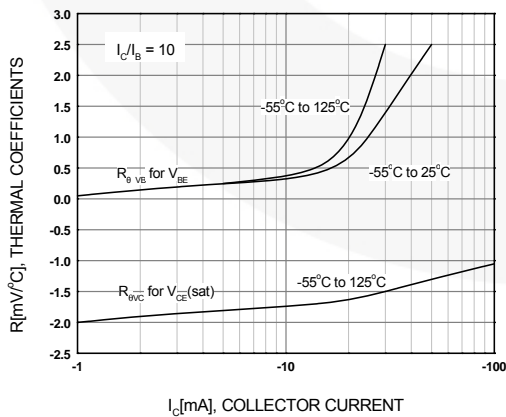


Figure 5. Temperature Coefficients

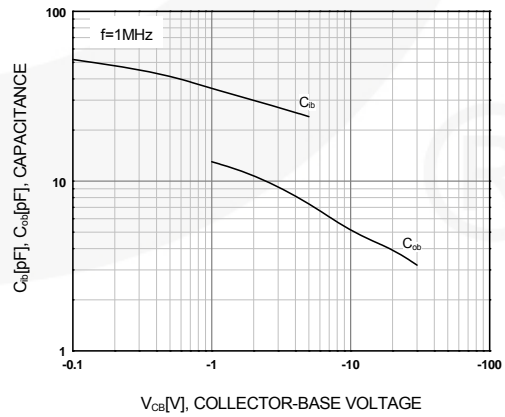


Figure 6. Capacitance

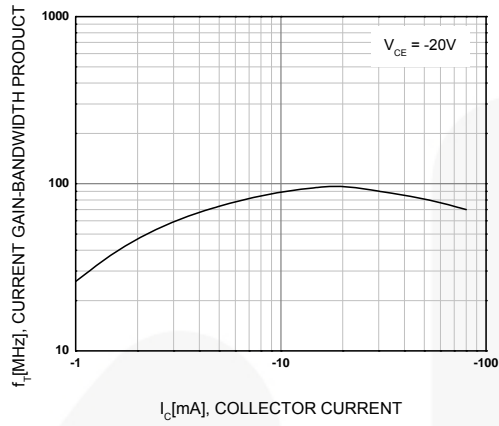


Figure 7. Current Gain Bandwidth Product

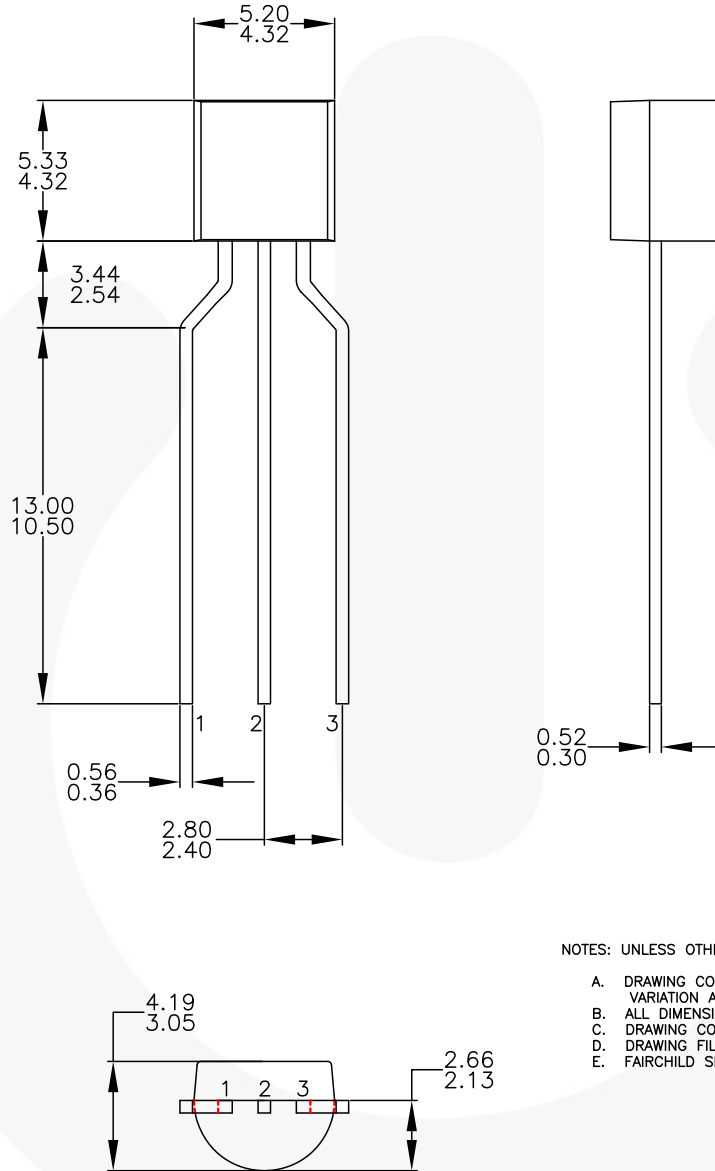







Figure 8. 3-Lead, TO-92, Molded, 0.2 In Line Spacing Lead Form, Ammo Type
