



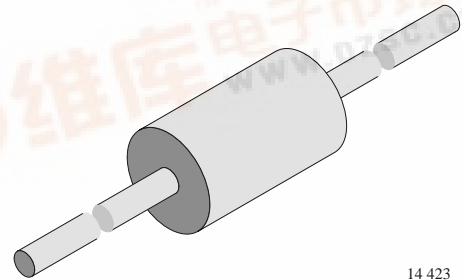

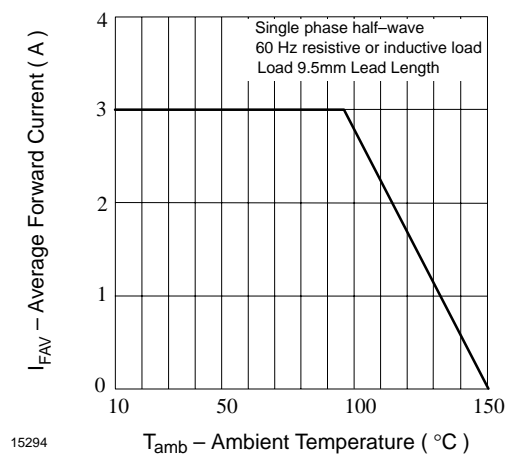


Figure 1. Max. Average Forward Current vs. Ambient Temperature

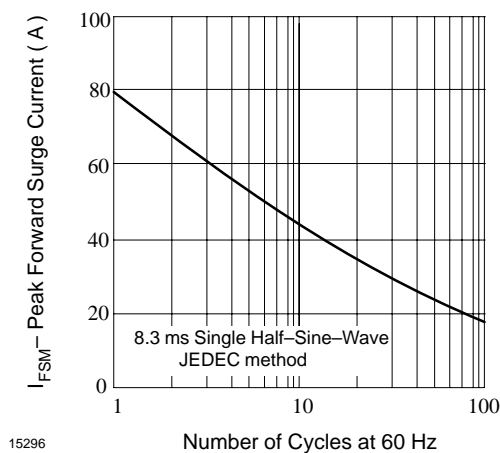


Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles

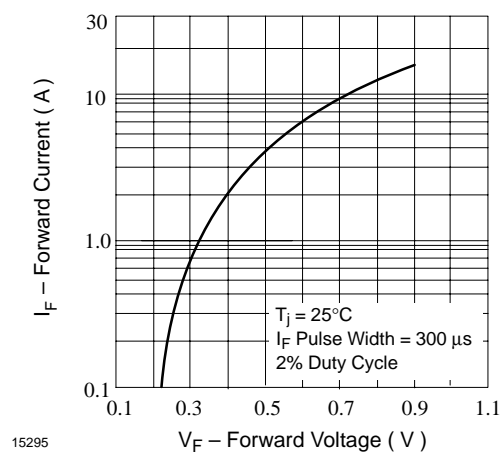


Figure 2. Typ. Forward Current vs. Forward Voltage

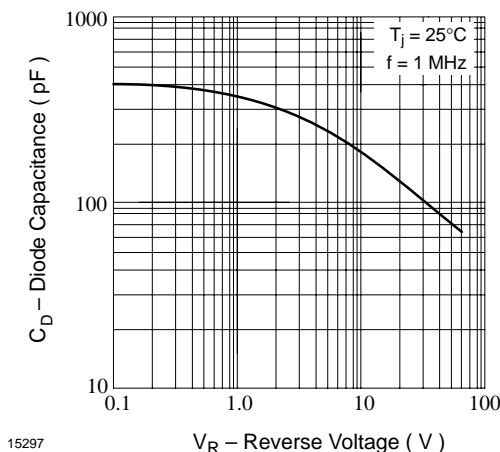


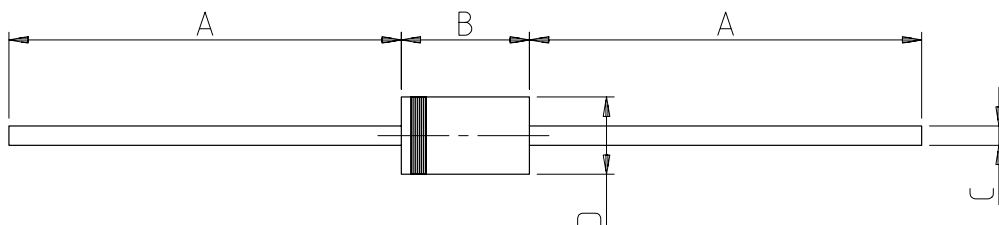
Figure 4. Typ. Diode Capacitance vs. Reverse Voltage



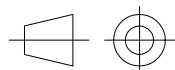

1. Meet all present and future national and international statutory requirements.

3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.
