


Figure 1. Max. Average Forward Current vs.
Ambient Temperature




Figure 2. Typ. Forward Current vs. Forward Voltage




Figure 3. Max. Peak Forward Surge Current vs. Number of Cycles




Figure 4. Typ. Diode Capacitance vs. Reverse Voltage





Figure 5. Typ. Reverse Current vs. Percent of Rated Peak Reverse Voltage
