

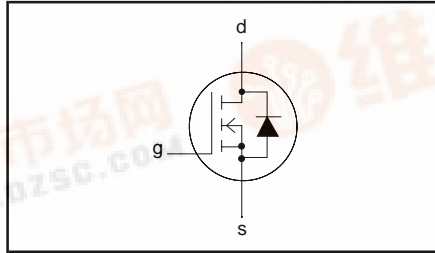

GENERAL DESCRIPTION

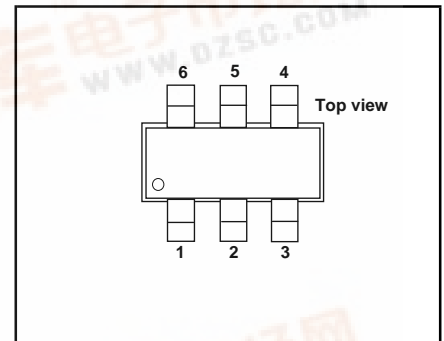

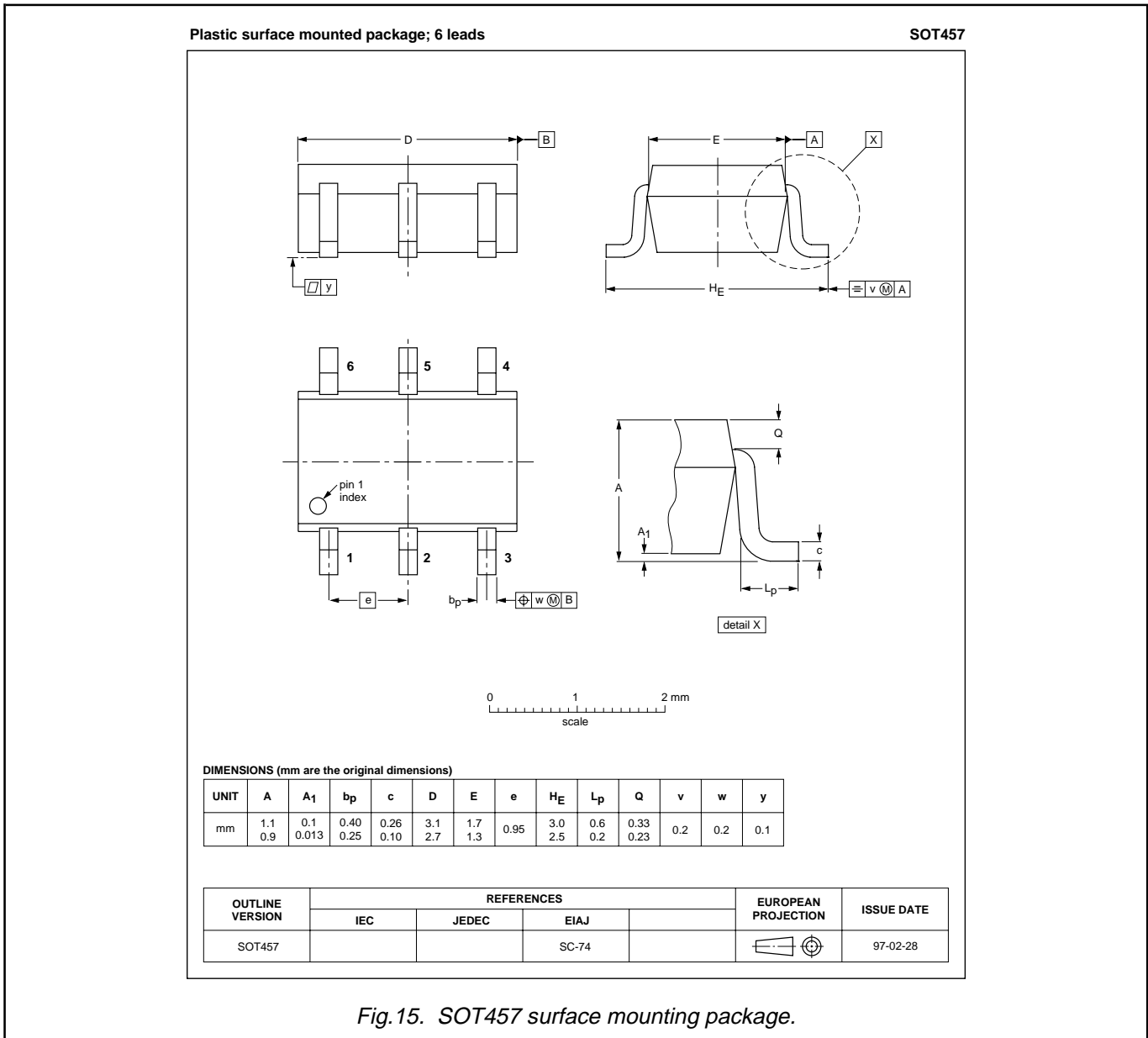


Fig. 15. SOT457 surface mounting package.
