

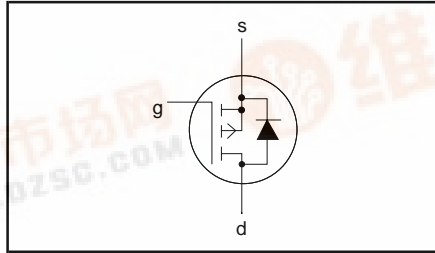

GENERAL DESCRIPTION

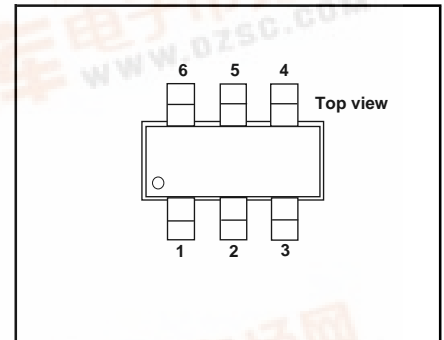

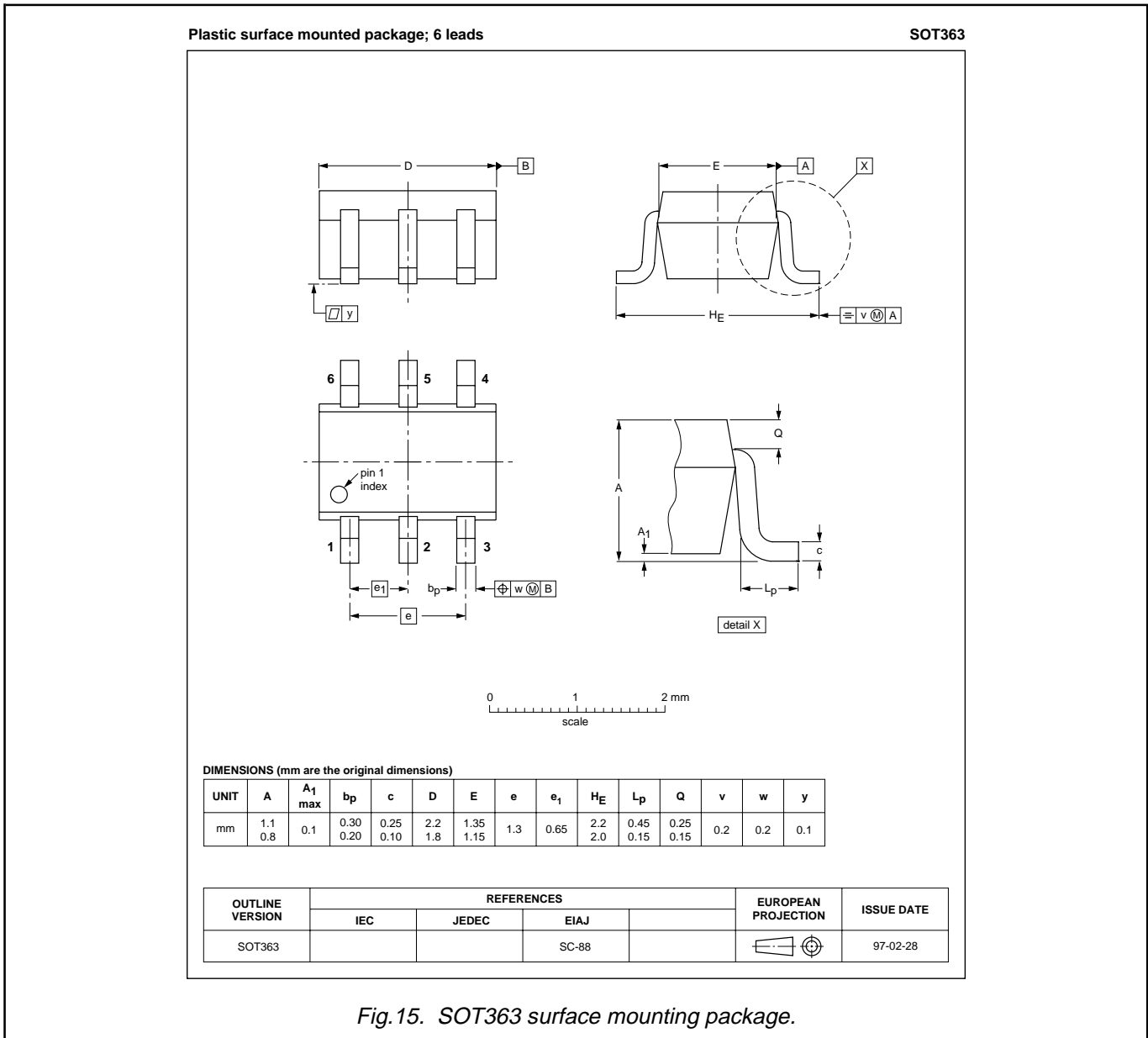


Fig. 15. SOT363 surface mounting package.
