






Figure 1. Max. Thermal Resistance vs. Lead Length




Figure 2. Max. Average Forward Current vs. Ambient Temperature




Figure 3. Max. Average Forward Current vs. **Ambient Temperature**




Figure 4. Junction Temperature vs. Reverse/Repetitive Peak Reverse Voltage




Figure 5. Reverse Current vs. Junction Temperature




Figure 6. Max. Forward Current vs. Forward Voltage





Figure 7. Typ. Diode Capacitance vs. Reverse Voltage

Ozone Depleting Substances Policy Statement

It is the policy of Vishay Semiconductor GmbH to

- 1. Meet all present and future national and international statutory requirements.
- 2. Regularly and continuously improve the performance of our products, processes, distribution and operating systems

- 2. Class I and II ozone depleting substances in the Clean Air Act Amendments of 1990 by the Environmental Protection Agency (EPA) in the USA
- 3. Council Decision 88/540/EEC and 91/690/EEC Annex A, B and C (transitional substances) respectively.

Vishay Semiconductor GmbH can certify that our semiconductors are not manufactured with ozone depleting substances and do not contain such substances.
