


Figure 1. Static Characteristic




Figure 3. Saturation Voltage




Figure 5. Reverse Bias Safe Operating Area




Figure 2. DC current Gain




Figure 4. Saturation Voltage




Figure 6. Forward Bias Safe Operating Area




Figure 7. Resistive Load Switching Time






Figure 8. Power Derating
