


Figure 1. Forward Current vs. Forward Voltage




Figure 2. Forward Current vs. Forward Voltage




Figure 3. Reverse Current vs. Reverse Voltage




Figure 4. Diode Capacitance vs. Reverse Voltage





Figure 5. Board for  $\mathrm{R}_{\mathrm{thJA}}$  definition (in mm)
