


Figure 1. Reverse Current vs. Junction Temperature




Figure 2. Forward Current vs. Forward Voltage




Figure 3. Diode Capacitance vs. Reverse Voltage





Figure 4. Board for R<sub>thJA</sub> definition (in mm)
