






SN54ALS133 . . . FK PACKAGE (TOP VIEW)





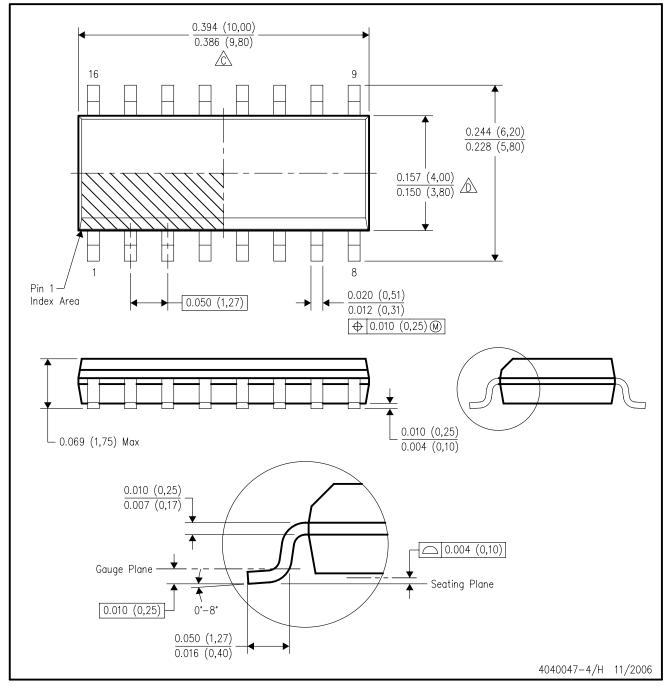
