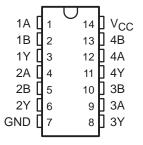

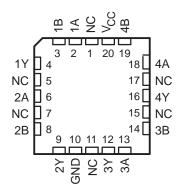

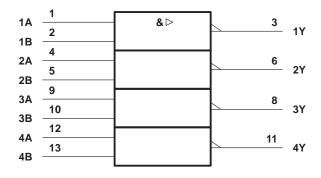


# SN54AS1000A . . . FK PACKAGE (TOP VIEW)

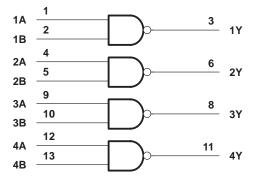

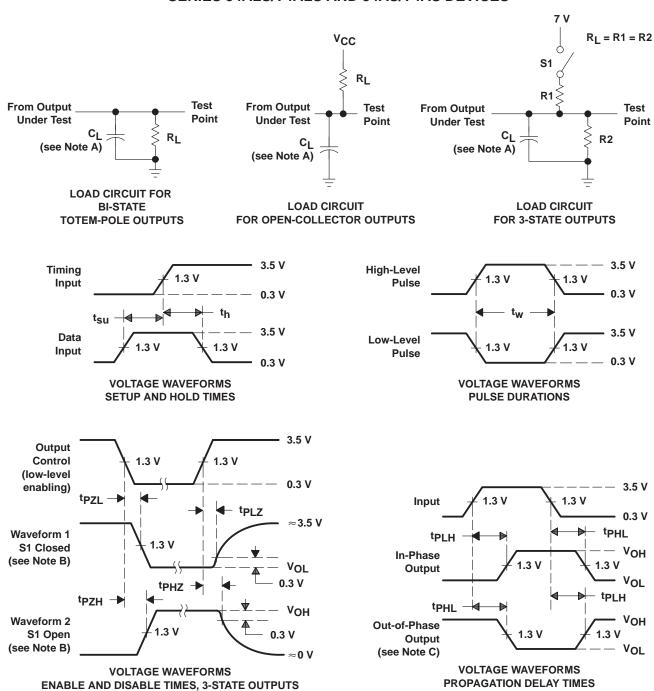
