

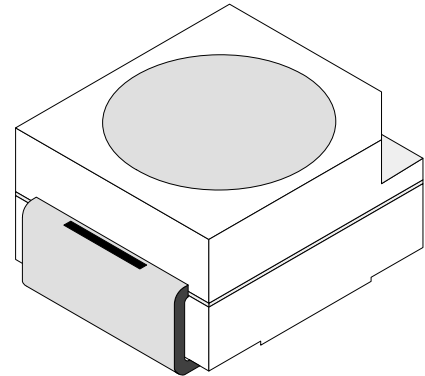

The package of the TLMD3105 is the P-LCC-2 (equivalent to a size B tantalum capacitor). It consists of a lead frame which is surrounded with a white thermoplast. The reflector inside this package is filled up with clear epoxy.

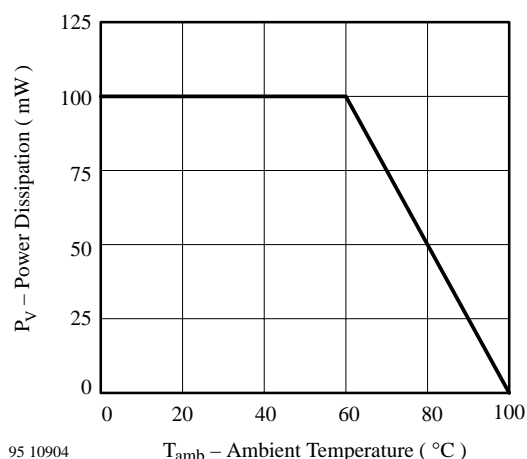


Figure 1 Power Dissipation vs. Ambient Temperature

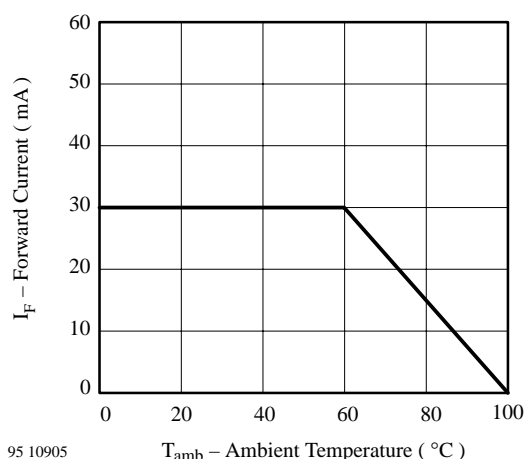
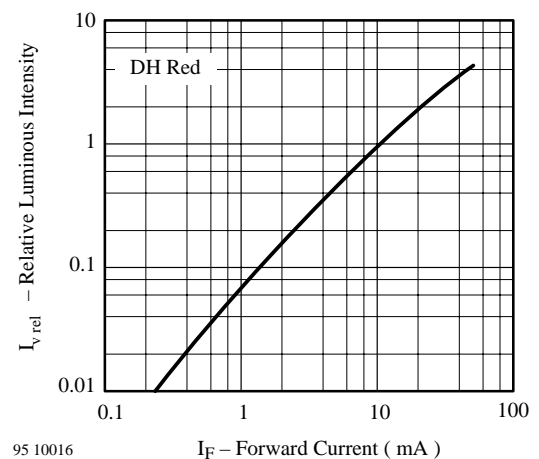
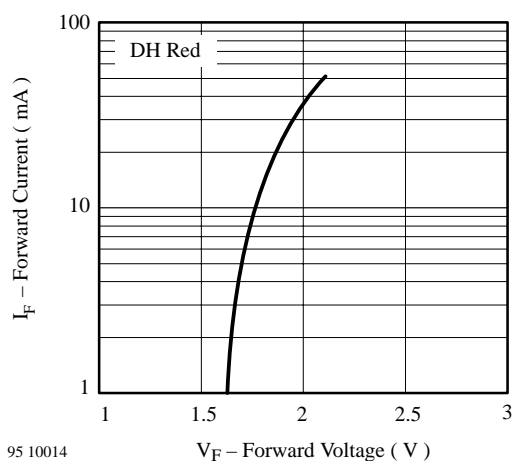
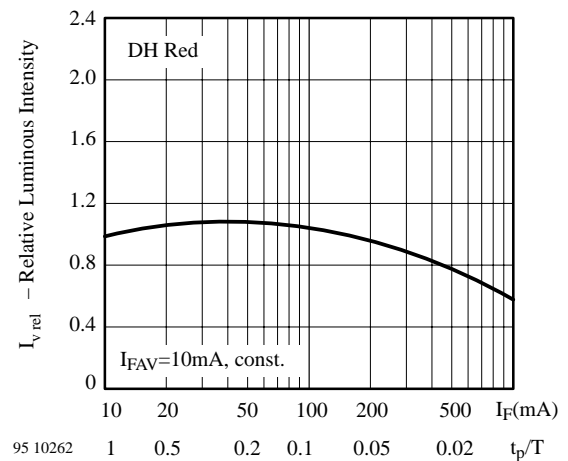
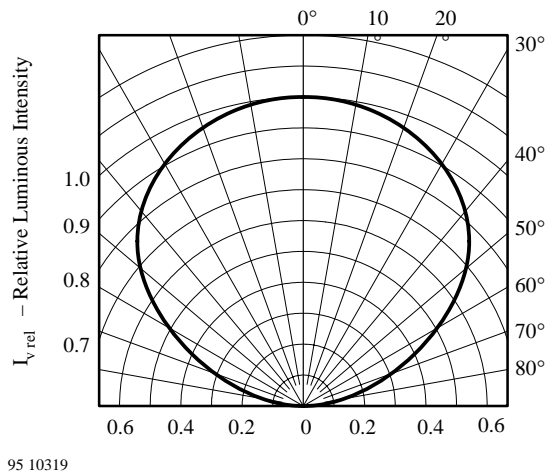
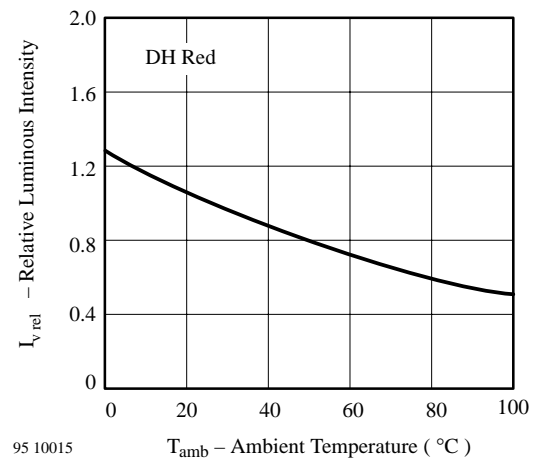
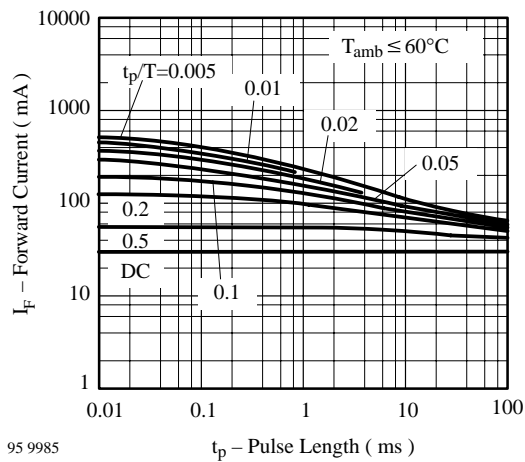
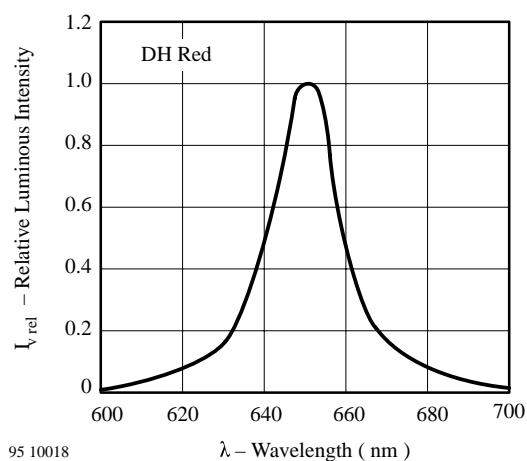


Figure 2 Forward Current vs. Ambient Temperature

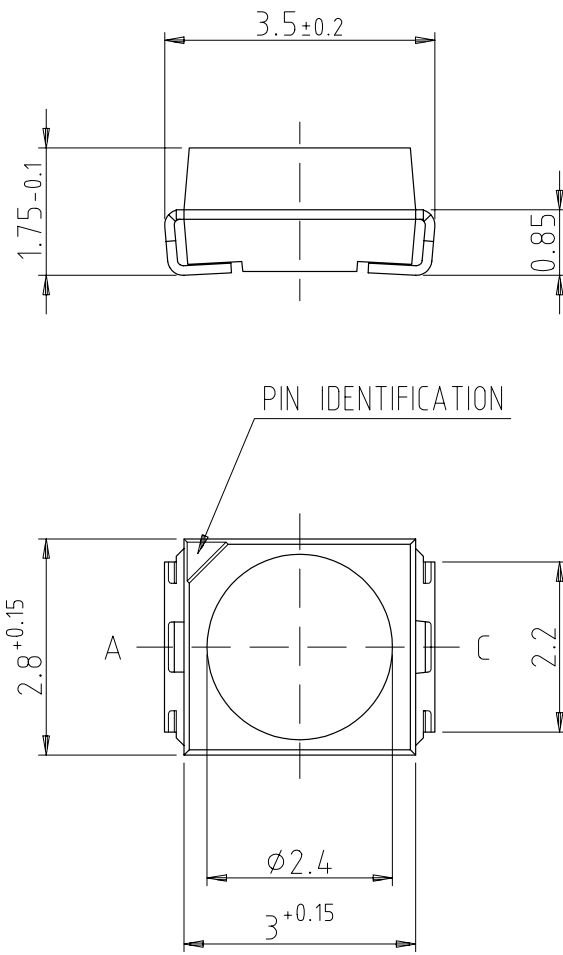

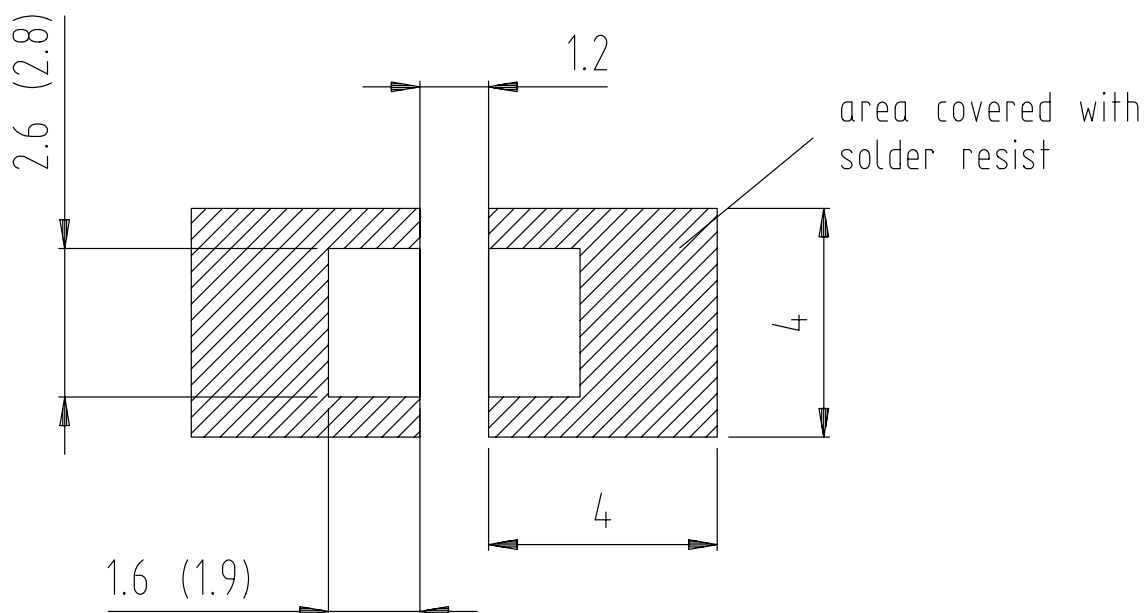
Figure 9 Relative Luminous Intensity vs. Wavelength
