



It utilizes Schottky circuitry and has TTL-compatible outputs. The inputs are compatible with either a single-ended or a differential-line system. This device operates WWW.DZSC.COM from a single 5-V power supply and is supplied in an 8-pin, dual-in-line package.


The uA9639C is characterized for operation from 0°C to 70°C.

logic diagram











Figure 1. Test Circuit and Voltage Waveforms








TYPICAL CHARACTERISTICS
