

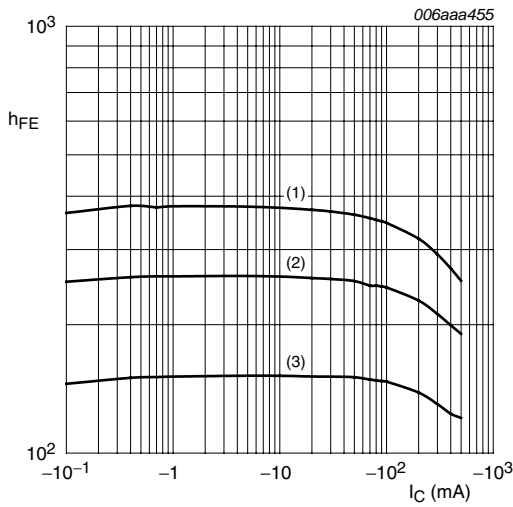

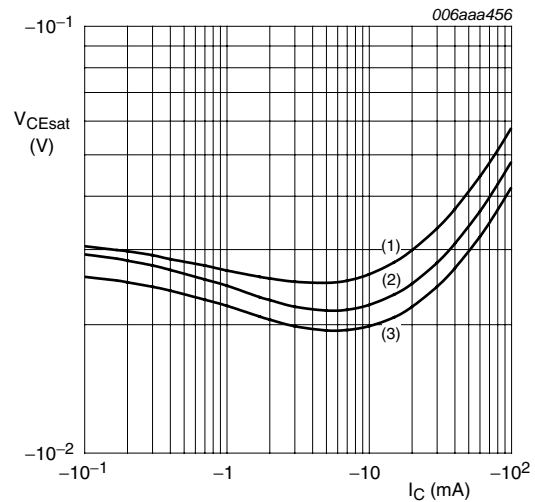

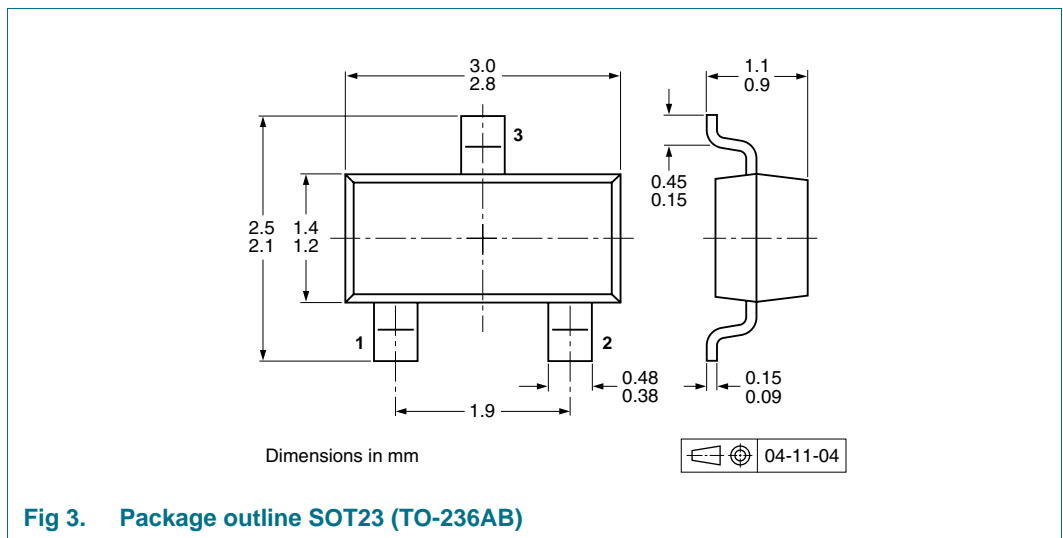
**Fig 2. Collector-emitter saturation voltage as a function of collector current; typical values**

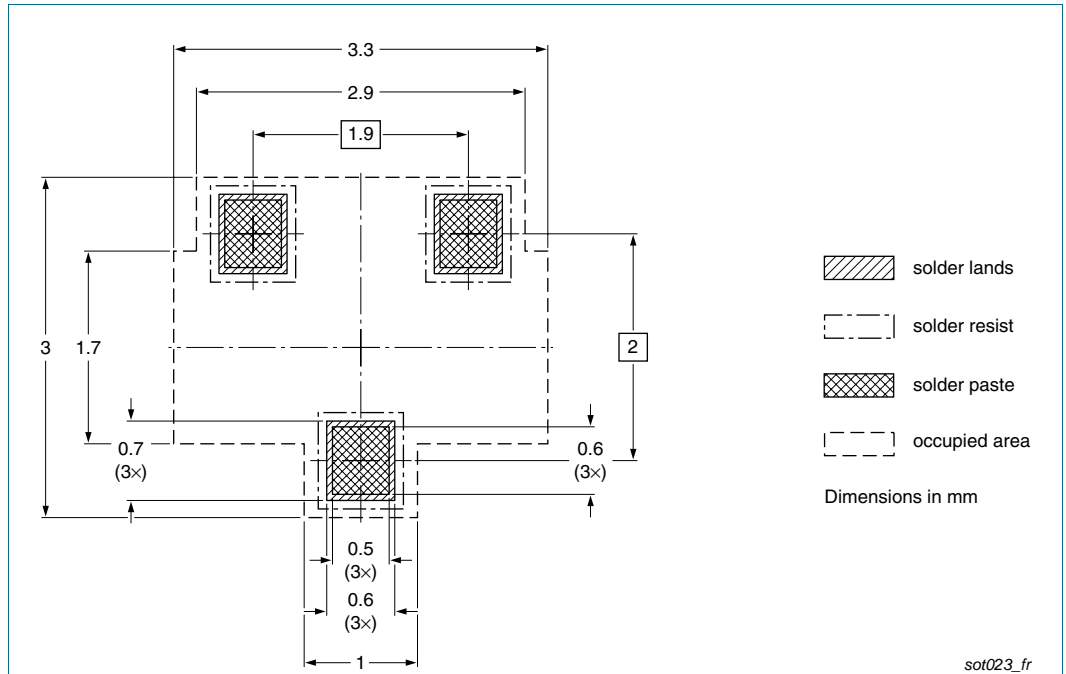


Fig 4. Reflow soldering footprint SOT23 (TO-236AB)

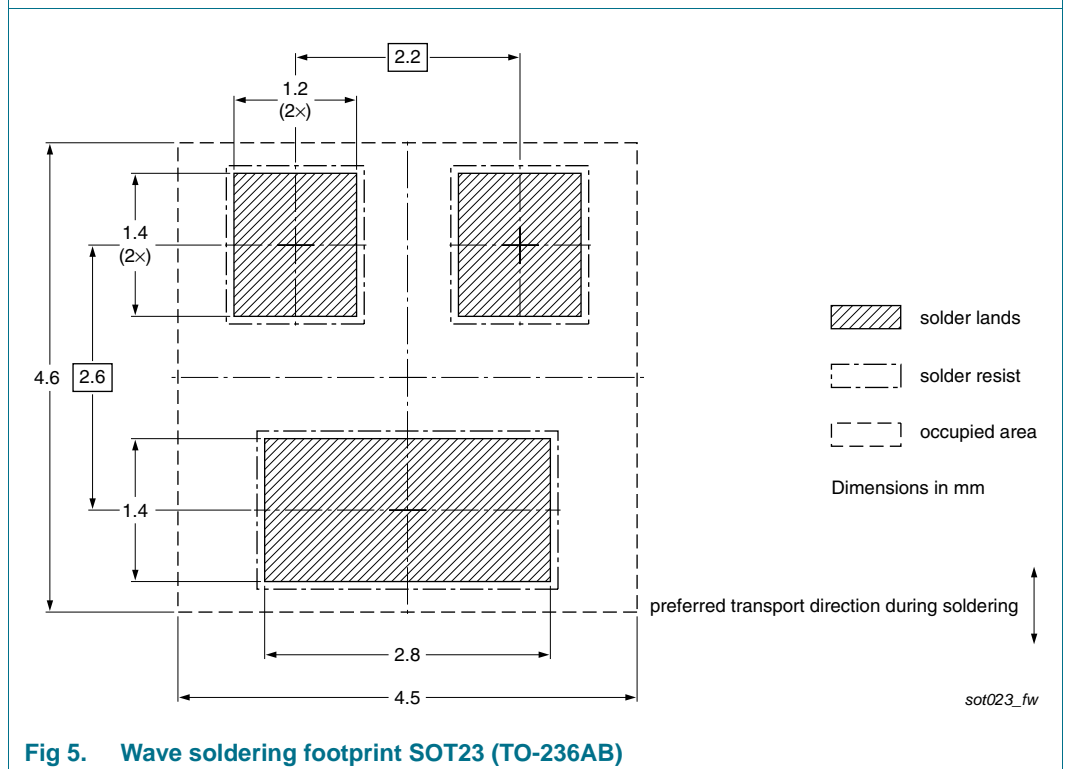


Fig 5. Wave soldering footprint SOT23 (TO-236AB)
