This transistor is ideal for high-precision control such as PWM control for pulse motors or brushless motors in OA and FA equipment.





SWITCHING TIME (ton, tstg, tf) TEST CIRCUIT












FORWARD BIAS SAFE OPERATING AREA







DERATING CURVE OF SAFE OPERATING AREA




TRANSIENT THERMAL RESISTANCE







